

## October 2017 MINUTES

1. Michael Cossman (Brenda Shelton) motion to approve agenda with the addition of 11B. – Classified. Motion carried.
2. Michael Cossman, (Roy Hargadine) motion to approve September minutes as written. Motion carried.
3. There were no comments from patrons.
4. Sheriff Walker was unable to attend. Crisis Plan will be discussed next meeting.
5. Superintendent Chaney informed the board that the campus is in good shape but would like the board to be thinking of any upcoming projects they would like to see done.
