1. Scott Bradford (Michael Cossman) motion to approve agenda with the addition of 5F – Bonds. Motion carried.
2. Scott Bradford (Brenda Shelton) motion to approve March minutes as written. Motion carried.
3. There were no comments from patrons.
4. Superintendent Chaney informed the board that D.V. Douglass and Stewart Plumbing has been out and are in the process of getting us bids for the high school roof. The landscaper from Great Bend came out and visited about the high school lawn. A bid for sprinkler and landscaping should be coming soon.
